**FOOD VENDOR INFORMATION & APPLICATION**

Sullivan County Park & Lake (SCPL) will host the annual Fireworks over the Lake Freedom Festival **Friday, July 2 – Sunday, July 4, 2021.**

**Hours of Operation:**

<b>Friday, July 2, 2021</b>	5:00 pm – 11:00 pm	6 hours
<b>Saturday, July 3, 2021</b>	11:00 am – 11:00 pm	12 hours
<b>Sunday, July 4, 2021</b>	11:00 am – 3:00 pm	4 hours

**Vendor Participation:**

There is a designated section within the Park for food vendors to sell their products during the festival. Vendor can rent a space to exhibit and sell their products on a first come, first serve basis by completing the enclosed form via US mail or at the Park Office **no later than Friday, June 25, 2021.**

Vendors must have general liability insurance coverage and must comply with applicable local and state health, fire and public safety codes. Vendors are solely responsible for meeting all Health Department Certifications. Vendors may contact the Sullivan County Health Department at (812) 268-0224 for health code requirements and questions.

The fee to participate as a food vendor is \$75.00 for the 3-day event. SCPL will provide one 40' L x 15' W vendor space. Vendors must furnish their own tables, chairs, tents, booths, vending vehicle or trailers.

**Set-Up / Tear-Down:**

Vendors will be allowed to set up beginning Thursday evening, **July 1st** from 5:00 pm to 8:00 pm or **Friday, July 2nd** from 8:00 am – 3:00 pm. All vendors must be set-up no later than 4:00 pm on **Friday, July 2, 2021.** All vendors are required to operate until at least 9:00 pm Friday and Saturday and, if desired, may continue operating until 11:00 pm. Vendors are requested to remain open all hours of operation Saturday and Sunday. Final teardown will not be permitted until 3:00 pm **Sunday, July 4, 2021.** Vendor will be responsible for removing all trash and debris from their space.

**Electrical Power & Water:**

Each space will have available one 110 volt, 30 amp electrical circuit at no additional cost. Water will also be included. 220 volt power is available in a limited number of spaces.

**Accommodations:**

**Campsites are available for vendors with a recreational vehicle free of charge.** Cabin rentals, ranging from **\$38.00 to \$86.00** per night, are available on a limited basis. Cabin rental requires an advance reservation. Cabin rentals should be reserved directly by contacting the SCPL office at (812) 268-5537. Primitive (tent) camping is also available free of charge to vendors.
